General Rules

1. Students must attend classes in time and under no circumstances, leave the classroom without the permission of the class teachers. Irregular attendance may result in their being struck off from the registers.
2. The student should collect their caution money within a period of six months after completion of the course of study, failing which the money will be forfeited and deposited in the Government Treasury.
3. Serious action will be taken against any student found taking part or associating in any way with disorderly proceedings within the College premises.
4. Every student shall carry on regularly his/her identity card issued by the College immediately after admission and get the same renewed every year.
5. Students have to maintain proper decorum, to follow the rules and regulations of the Institute, and to pay due respect to the Faculty and other officials.
6. Damage to the College property (fixtures, fittings, instruments, furniture, books/periodicals, vehicles, building, etc.) shall be viewed seriously and might result in instant expulsion of the guilty students from the College.
7. The students are expected to have 100% attendance at classes as per the regulation of the Goa University. However, a minimum of 75% attendance is essential. Students must appear for Terminal Examination conducted by the College at the end of First term, failing which he/she will not be allowed to appear for the University/College Examination.
8. The Ragging is banned in the College and any one found indulging in “ragging”, is likely to be punished, which may include expulsion from the College.
9. Students are required to strictly abide by the code of Conduct and any lapse will be dealt with according to the rules and regulations of the College/University.
10. In case of damage of furniture, Instruments/equipments of the College/Kala Academy Goa, the cost of repairs or replacement will be charged to the student responsible for the damage. The management may impose collective fines to compensate for any such damage.

11. Students must keep their guardians informed of their progress by updating them about their performance in the regular assignments/tests, etc. Parents and guardians must realise that the training of their wards is their joint responsibility and check the progress, conduct, regularity of their wards through their respective teachers personally. Parents must come to meet the Principal without fail whenever they are called.
12. All parents/guardians shall witness the productions of college of Theatre Arts from time to time to check and test the progress of their warden.
13. Consuming alcohol, tobacco in the college and hostel premises is strictly prohibited.
14. Students are not allowed to invite visitors or friends to classes, lectures or rehearsals.
15. It is obligatory for the students to enact any role that they are handed. They must participate in rehearsals and perform the role in the manner required by the lecturers or the Directors of the play.
16. Students violating rules are liable to severe disciplinary action.
17. Students has to stay late during performance related work/Rehearsal, they should intimate their parents/Guardians and make alternate arrangement for stay, Kala Academy will try to provide shared accommodation.

Do's

- Do carry/wear your identity card at all times. You may be asked to leave the campus if you don't. Apply for a duplicate I-card incase yours is lost.
- Do be on time for all your lectures/practicals. You may not be allowed to enter the classroom/labs late.
- Do take care of the college property and keep it clean and tidy.
- Do submit your filled in justification form in case you remain absent for lectures/practicals/I.S.A.s / S.E.Es within three days of your rejoining the college.
- Do read the Notice Board and visit the College website regularly.
- Do meet the Principal/Vice-Principal in case you have any problem or grievance pertaining to the college.
- Do participate in the co-curricular activities of the college during your spare time.
- Do be courteous to other students and to all the teaching and administrative staff.
- Do maintain good moral and social behavior at all time.

Don't's

- Do not use unbecoming/indecent language or conduct in the class/campus. This may lead to suspension or dismissal.
- Do not attend lectures other than your own, except with special permission from the lecturer concerned.
- Do not damage the fixtures and fittings in the college campus.
- Do not smoke, consume liquor, drugs or other intoxicants.
- Do not use mobile/cell phones in the classrooms, laboratories and library.
- Do not talk/discuss/create disturbance in the Library.

LIBRARY RULES FOR STAFF AND STUDENTS

I] Membership:

The primary library members include Principal, Faculty members, Students and administrative staff of the institute. Ex-Students may however avail the library facilities with prior approval from the Principal.

Any user who is leaving the Institute must get the NO DUES form signed from the Librarian, ensuring that all the materials(books/CD/periodicals) borrowed from the library have been returned and over-due charges, if any ,have been paid.

II] Borrowing / Loan Privileges:

A. General Rules

1. New additions to the library will be issued to the users only after complete processing is done.
2. The library can recall the books issued to the user at any time, if required.
3. Users will be responsible for the materials borrowed from the library.
Borrower will be charged for any loss, damage to the material(s), by way of mutilation and disfiguring of pages, by either asking for a replacement of the document (latest /same edition). In case of out of print documents, the member will have to pay an amount equal to the cost of document + processing fee of Rs 100/-.
4. Users are requested to ensure that all the documents taken out of the library are properly issued.
5. Users have to compulsorily sign on the entry register of the library

B. For Students

The maximum number of library materials which can be issued

i. Textbooks = 2

ii. Magazines (back-dated) = 2

iii. Reference Material =1

- a. Students need to produce their library card in person while borrowing books and other materials from the library.
- b. Loan Period for books = 7 days
- c. Renewal of books will depend on the demand from other users.
- d. Library cards are non-transferable.
- e. Library materials issued for photocopying/Xeroxing are to be returned within 24 hrs from the time of issue , failing which students will be liable to pay a fine of Rs. 20/- Per day
- f. Overdue Charges = Rs. 5 per day
- g. Loss of Library Card / Refund of library deposits will be as mentioned in the prospectus.

III] The following will be treated as misconduct and they will be reported to the authorities

1. Unauthorized removal of library materials.
2. Mutilation and disfiguring of library materials.
3. Non-response to the intimations of library for return of materials.
4. Misbehavior with the library staff on duty.

BPA (Theatre) Ordinances & Programme Structure

The syllabus of Bachelor of Performing Arts (Theatre) Programme has been prepared by Board of Studies in Performing Arts (Theatre) and approved by the Academic Council of Goa University. It includes Dramatic Literature and Theatre History, Stage Craft and Theatre Techniques, Acting, Direction and Play Departmental Production.

The main thrust is on the participation of the production process itself. However, the aim is to give students exposure to the complete milieu of Theatre.

The four year is divided into 8 semesters. The fourth year consisting of semester VII and VIII offer specialization in the chosen area of Theatre art.

Please refer to the ordinances approved by Goa University that govern this programme which are produced below:

Goa University Ordinance OC-60 relating to Bachelor of Performing Arts (Theatre)– B.P.A.(T)

OC-60 Ordinance relating to Bachelor of Performing Arts (Theatre) B.P.A.(T)

OC-60.1 Aim and Objective of the Programme

The objective of this Programme is to impart a full time professional training in Performing Arts (Theatre) leading to the Degree of Bachelor of Performing Arts (Theatre). It aims at creating trained graduates in Performing Arts dedicated to theatre.

OC-60.2 Duration of the Programme

Duration of the Bachelor of Performing Arts (Theatre) Programme shall be of four academic years consisting of a total of eight Semesters.

OC-60.3 Eligibility and Admission

Candidates who have passed Higher Secondary School Certificate Examination HSSCE (Std. XII) or an equivalent examination of a recognized Board/Body and pass the Entrance Examination with a minimum of 40% marks, as well as successfully clear the interview for selection conducted by the Institution offering the Programme, shall be eligible for admission to the B.P.A.(T) Programme.

OC-60.4 Structure and Syllabus of the Programme

Structure and Syllabus of the Bachelor of Performing Arts (Theatre) Programme shall be as specified below:

OC-60.4.1 Structure

- (i) The Programme shall consist of a total of four academic years of eight Semesters.
- (ii) There shall be five courses in Theory, one course in Performance (Practical), and a course on Environmental Studies, in each of the Semesters I and II.
- (iii) There shall be six courses comprising Theory and Practical, in each of the Semesters III to VI.
- (iv) All Theory Courses shall carry three credits each. All non-Theory Courses including Practicals, Performances, and Graduation Projects shall carry four credits each.
- (v) One credit shall be equivalent to 15 lectures of one hour each or 15 practical sessions of three hours each.
- (vi) In addition to the Theory and Practical Courses, students shall be required to attend Workshops, Seminars, Guest lectures and Guest performances.
- (vii) The Scene Work/ Production which is a component of Practical Course shall have at least four weeks of teaching time, with a minimum of 18 hours per week and a maximum of 36 hours per week.

OC-60.4.2 Syllabus

The syllabus for the B.P.A.(T) Programme shall be as proposed by the Board of Studies (BoS) in the Subject and approved by the Academic Council, from time to time.

OC-60.5 Scheme of Examination

- (i) The pattern of examination shall comprise of Internal and External components of assessment for all Theory courses.
- (ii) The marks allocation for the Courses shall be as recommended by the BoS and approved by the Academic Council.
- (iii) A candidate is required to obtain not less than 40% marks to pass in each course.
- (iv) There shall be separate heads of passing in the theory and non-theory components of a course. However there shall be a combined head of passing for Internal and External component of theory courses.

OC-60.6 Attendance

To be eligible to appear for the External Examination at the end of each semester, the minimum semester-wise attendance for all Theory and Practical Courses shall be 75% as prescribed under Ordinance OA-17.

OC-60.7 Admission to higher Semester

- (i) A candidate admitted to Semester I shall be subsequently eligible for admission to Semester-II provided he/she has 75% attendance in Semester-I.
- (ii) From Semesters III to VIII, a candidate shall be eligible for admission to the next semester, provided that he/she has passed in all the Theory and Practical/ Performance courses of all, but the immediate preceding, semesters, and must have 75% attendance in the immediate preceding Semester.

OC-60.8 Revaluation

A student may apply for revaluation in the External component of assessment of the course as prescribed under Ordinance OA-5.15.

OC-60.9 Exemption

A student who obtains minimum passing marks prescribed in each theory paper shall be exempted from reappearing for that paper only.

OC-60.10 Examiners

OC-60.10.1 Board of Examiners

For each Course there shall be one Internal Examiner and one External Examiner. The appointment of Examiners shall be as per Ordinance OB-4.

OC-60.10.2 Eligibility for appointment as External Examiner

Master's Degree or its equivalent in the relevant subject from a recognized University, and minimum of three years teaching experience at undergraduate level.

OR

A performing artist having excellence in the subject concerned and having a minimum of eight years experience as a performer.

OC-60.11 Setting of question papers

The question papers for external examinations for all semesters shall be set by internal examiners in consultation with the external examiners. Internal examiner shall be the Convener of the Board of Examiners for the respective course. The same examiner may be appointed as the Convener for more than one paper, if required. The Performance/ Practical examinations of a course shall be conducted jointly by the internal and external examiners.

OC-60.12 Declaration of Results and award of Grades

(i) While declaring the results, Grades shall be awarded as prescribed under Ordinance OA-16, to the candidates who have appeared for the Final Semester Examination based on their cumulative performance of all eight semesters.

(ii) Eligible candidates shall be awarded grace marks as prescribed under Ordinance OA-5.16.

(iii) A candidate desiring to improve his/her Grade shall be permitted to do so as per the University rules governing the same.

OC-60.13 Repeat Examination

A student failing in Final Year (Semester-VII and Semester-VIII) Examination shall be eligible to appear in the next examination as an external candidate and complete the Programme within a total period of eight years from the date of registration for Semester-I. In case, a student has failed in a Production or any group practical work, he/ she will have to attend the necessary classes again to reappear for the examination. Appropriate fees shall be charged for the same.

Refund of Fees

(As per Circular No. 36/Acad-PG/Refund of Fees/2017/1322/446 dated 17/05/2017)

If a student chooses to withdraw from the programme of study in which he/she is enrolled, the following four tier system shall be followed for the refund of fees remitted by him/her.

Sr. No.	Point of time when notice of withdrawal of admission is served to the college/University	% of refund of Aggregate fees*
1	15 days before the formally notified last date of admission	100%
2	Not more than 15 days after the formally notified last date of admission	80%
3	More than 15 days but less than 30 days from formally notified last date of admission	50%

In case of (1) in the table above, 10% of the aggregate fees shall be deducted as processing charges from the refundable amount.

- Fees shall be refunded to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.
- The students who have already been admitted to a programme of the University and have paid the fees and are subsequently admitted to another programme shall have to pay the fees for the final admission and claim the refund of fees paid earlier, in which case no administrative charges shall be deducted from fees paid earlier by the student.
- All other cases of the refund of the fees will be decided on case to case basis in its merit.

Annexure-I: UGC Regulations on Anti-Ragging

UNIVERSITY GRANTS COMMISSION

UGC REGULATIONS ON CURBING THE MEANCE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009.

**(Under Section 26 (1) (g) of the University Grant
Commission Act, 1956) Dated June, 2009**

PREAMBLE

In view of the Directions of the Hon'ble Supreme Court in the matter of “University of Kerala V/S Council, Principals, Colleges and others” in SPL no. 24295 of 2006 dated 16.05.2007 and that dated 08.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grant Commission to Prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students, which causes or likely to cause annoyance, hardships or psychological harm or to raise fear or apprehension thereof in any fresher or any other students, or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institution in the country, and thereby, to provide for the healthy development, physically or psychologically, of all students, the University Grant Commission, in consultation with the Councils, brings forth this Regulation.

In exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the University Grant Commission hereby makes the following Regulations, namely

What constitutes Ragging?

- a. Ragging constitutes one or more of any of the following acts: a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. Indulging in rowdy or indisciplined activities by any student or student which cause or likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c. Asking any student to do any act which such student will not in the ordinary course to do and which has the effect of causing or generating a sense of shame, or torment or

embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;

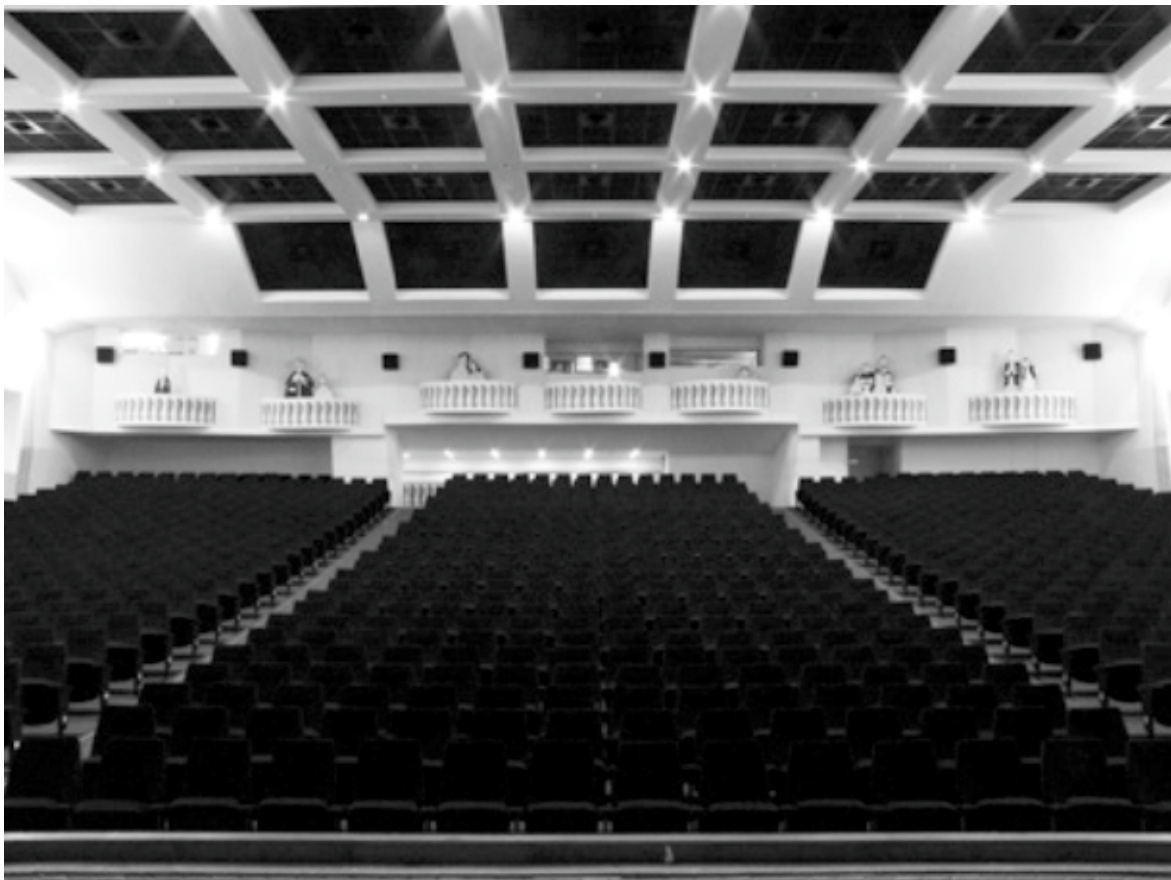
- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher,
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- i. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student

Administrative action in the event of Ragging:

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:

- a) The Anti-Ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti- Ragging Squad, award, to those found guilty, one or more of the following punishments, namely :
 - I. Suspension from attending classes and academic privileges.
 - II. Withholding / withdrawing scholarships / fellowship and other benefits.
 - III. Debarring from appearing in any test / Examination or other evaluation process.
 - IV. Withholding results.

- v. Debarring from representing the institution in any Regional, National or International meet, tournament, youth festival, etc.
 - vi. Suspension / expulsion from the hostel.
 - vii. Cancellation of admission
 - viii. Rustication from the institution for a period ranging from 1 to 4 semesters.
 - ix. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
 - x. Fine which may extend up to 2.5 lakhs. Provided that where the person committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- b) An appeal against the order of punishment by the Anti-Ragging Committee shall lie;
- i. In case of an order of an institution, affiliated to or constituent part, of a University to the Vice-Chancellor of the University;
 - ii. In case of an order of a University, to its Chancellor.
 - iii. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.
